The primary mission of Girls on the Run - Sierras (GOTR-S) is to educate and prepare girls for a lifetime of self-respect and healthy living. To accomplish this, GOTR-S combines training for a 5K (3.1 miles) running race with healthy living education, with education and classes over a 12-week period at local schools. GOTR-S programs instill self-esteem and strong values through health education, life skills development, mentoring relationships, and physical training - all of which are accomplished through an active collaboration with girls and their parents, schools, volunteers, staff, and the community.

GOTR-S sponsored two 12-week training programs at elementary schools or other sites in the Tahoe-Truckee Unified and Washoe County School Districts, in which participating girls not only trained physically for a 5 kilometer run, but learned self-respect and habits of a healthy lifestyle. The training programs were held at five different elementary schools or sites in the Truckee/Lake Tahoe area. A total of approximately 47 girls participated in the Fall program, with approximately 68 participating in the Spring program.
